## **EMIL FRANKEL JOINS PARSONS BRINCKERHOFF**

NEW YORK, NY – Emil H. Frankel, former assistant secretary for transportation policy at the U.S. Department of Transportation, has joined Parsons Brinckerhoff (PB), an international consulting, engineering and program management organization.

From 1995 to 2001, Mr. Frankel was Of Counsel to Day, Berry & Howard in the law firm's Stamford, Connecticut, office. During that time he was also a management fellow at Yale University's School of Management and a senior fellow at the School of Forestry and Environmental Studies, engaged in teaching and research on issues of transportation and environmental policy and public management. In 1995, he was a joint fellow at the Center for Business and Government and the Taubman Center for State and Local Government at Harvard University's Kennedy School of Government.

Mr. Frankel was commissioner of the Connecticut Department of Transportation from 1991 to 1995, responsible for managing an agency with over 4,100 employees and an annual budget of approximately \$1 billion. Previously, he served as a special assistant to the under secretary at the U.S. Department of Housing and Urban Development, and as a legislative assistant to U.S. Senator Jacob K. Javits.

Mr. Frankel is a member of the American Association of State Highway and Transportation Officials and chairman of the organization's Standing Committee on the Environment. He served as vice chairman of the I-95 Coalition and was a director of the Regional Plan Association in New York. He earned an LL.B. degree from Harvard University and a B.A. from Wesleyan University, and was a Fulbright Scholar at Manchester University in the United Kingdom. He was a trustee of Wesleyan University from 1981 to 1997 and is currently a trustee emeritus. He served as a selectman of the town of Weston, Connecticut, from 1999 to 2001.
